THE CIVIL AVIATION (LICENSING OF AIR SERVICES) REGULATIONS, 2006

In accordance with the Civil Aviation (Licensing of Air Services) Regulations, 2006, the following revised fees to be charged for various licences became **applicable with effect from 1 July 2013**.
