THE TANZANIA CIVIL AVIATION REGULATIONS, (TCARS) 2006 - FEES.

In accordance with Tanzania Civil Aviation Regulations, 2006, the fees to be charged for various licences/ certificated/services/approvals are revised. These fees have been promulgated since 1996. The AIC also includes the following:-

- i) Fees for additional technical documents on sale in the TCAA.
- ii) Fees for aerodrome licensing/certification process which hitherto were included in AIC 05/2009 to align with and the current exchange rate of Tanzania Shilling against US Dollar.
- iii) Fee for construction of an aerial mast or structure.
