## CHARGES RELATED TO LICENSING OF AIR AND GROUND HANDLING SERVICES

In accordance with the Civil Aviation (Licensing of Air Services) Regulations, 2006 and the Civil Aviation (Ground Handling Services) Regulations, 2012 the following revised fees to be charged for various licences, became applicable with effect from 1 February 2019.
